



## **Active Threat Management Training**

### **Training that creates resilience during active threats.**

We like to think of New Zealand as a safe country. However, recent events have shown we are more vulnerable than we may think. The Ashburton Work and Income NZ incident, multiple school lockdowns and the tragic Mosque attack in Christchurch reveal an unexpected threat can arise anywhere, anytime. For that reason, it's essential you and your staff know how to respond. This course will show you how and is a must for all frontline staff.

### **About this course**

C4 has delivered Active Threat Management training for many years. In light of the current situation, we have revised this programme to meet client needs in a volatile world. The course is specific to the needs of your organisation and embeds your in-house Standard Operating Procedures and emergency planning. It includes specific scenarios around Active Armed Offender (Active Shooter), Armed Robbery Survival, Bomb (IED) Threat and Terrorism Awareness/Crowded Place Safety.

Our instructors have first-hand experience in planning and responding to high risk situations including bomb threat, weapons incidents, and terrorist attacks.

### **How this programme works.**

This programme is developed from the four main courses we deliver around Active Threat Management. It provides skills and knowledge for those working in areas where Active Threats are known to occur including:

- Sporting, tourism, entertainment venues and major events
- Shopping and business precincts
- Retail outlets
- Government buildings
- Educational facilities
- Places of worship
- Hotels and convention centres
- Public transport hubs

These courses are also available as stand-alone half day courses

### **Active Armed Offender (Active Shooter)**

An armed offender is an individual who is actively engaged in killing, attempting, or threatening to kill people, and who has demonstrated their intention to continue to do so. This session is designed to equip staff with the knowledge and skills to safely deal with an Active Armed Offender situation. It includes:

- Awareness of potential threat situations
- How to respond when an Active Armed Offender is in your vicinity
- How to respond when emergency services arrive
- How to create an Emergency Action Plan
- Leadership within an Active Armed Offender situation
- Behavioural Analysis skills



## Armed Robbery Survival

Research tells us the first 3 seconds will determine whether a person being robbed will survive or be seriously injured. Being untrained creates the risk of mistakes that could cost a life. Make sure your staff know what to do, by enrolling them in this practical session. It includes:

- Deterring potential robbers
- Establishing awareness of safety procedures and behaviour prior to, during and after a robbery
- Minimising the effects of an armed robbery on staff
- Supporting existing armed robbery response guidelines
- Assisting Police with providing information about the crime
- Preserving evidence and the crime scene



## Bomb Threat (Improvised Explosive Devices or IEDs)

In New Zealand, bomb threats or IED threats are much more common than is publicly advertised. For example, our largest District Health Board receives one a week and our largest university one a month. Even though most of the time these amount to nothing, it's a very easy way to threaten a person or organisation. This session is designed to equip staff with the knowledge and skills to safely plan for and react in emergency situations involving bomb threats. It aims to:

- Support the company's existing security and emergency response guidelines
- Provide key staff with the knowledge to reduce the physical and psychological affects to staff in the event of an emergency involving bomb threat
- Record information required for Police investigation



## **Terrorism Awareness/Crowded Places Safety**

Terrorism is the use of force against persons or property in violation of criminal laws for the purposes of intimidation, coercion, or ransom. It threatens the security of nations, communities, and individuals. While we think of terrorism as something that happens overseas, the tragic events in Christchurch show us that we are not immune. Acts of terrorism follow a predictable and consistent path from conception to execution.

### **What can we do?**

Although the terrorists do have a distinct advantage, they also have weaknesses that can be exploited. If we understand these weaknesses, we may be able to prevent an attack or at least be more prepared to react if a terrorist act does occur.

This course covers topics such as:

- Active Armed Offender (Active Shooter)
- Hostile Vehicle Attack
- Chemical Attack
- Biological Attack
- Bomb (IED) incident
- Crowded Place Safety guidelines

All courses follow guidelines issued by the NZ Police and the Australia-New Zealand Counter Terrorist Committee (ANZCTC).
